

THE CW SUPERCON SWEEPSTAKES
WATCH & WIN OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

2. **Eligibility.** Subject to the additional restrictions below, the THE CW SUPERCON SWEEPSTAKES ("Sweepstakes") is open to residents of the state of Kentucky and Indiana who are 18 years or older at the time of entry. Employees of Block Communications, WDRB-TV, MY 58-TV and WBKI-TV ("Sponsor"), and each of its respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. The term "family members" includes spouses, parents, grandparents, siblings, children, grandchildren and in-laws, regardless of where they live.

3. **How To Enter.** The Sweepstakes will begin at 5:00 a.m. Eastern Standard Time ("EST") on Sunday, November 18, 2018 and end at 11:59 p.m. EST on Tuesday, November 20, 2018 and again from Sunday, November 25, 2018 and end at 11:59 p.m. EST on Tuesday, November 27, 2018 (the "Sweepstakes Period"). Sponsor will be the official timekeeper for the Sweepstakes.

To enter, watch or record the shows on WBKI Channel 58.1 between the hours of 8:00PM and 10:00PM (the "Shows"), during the Sweepstakes Period. Each day during the Sweepstakes, Sponsor will randomly reveal a "Daily Code Word" in promotional commercials between the hours of 8:00PM and 10PM on WBKI Channel 58.1. When you see the Daily Code Word announcement, TEXT the Daily Word Code to **74574 by 11:59 p.m, EST each day** to enter the drawing for a chance to win the prize (as set forth below). Each day is a new Daily Code Word and additional chance to enter.

The Station will announce six separate Code Words, one each day over the course of the Sweepstakes Period. Only one code word entry limit per day, per person, per phone.

Message and data rates may apply. By providing your number, you agree to receive text messages/voice calls from Sponsor and/or their affiliates in connection with your entry text and this Sweepstakes. Consent is not required to buy goods and services.

To qualify as an official entry, (a) you must be watching or recording the Shows at the time the Daily Code Word announcement is broadcast; (b) you must text the correct Daily Code Word to 74574 before 11:59pm, the same day the Daily Code Word is announced; and (c) you must comply with all other terms and conditions of these Official Rules. The determinations of Sponsor and Sweepstakes operators will be final and binding in all respects.

Sponsor reserves the right to disqualify any entries by persons who submit false or misleading entry information or who Sponsor determines to be tampering with or abusing any aspect of the Sweepstakes.

4. **Winner Selection and Odds.**

Sponsor will select winners in a random drawing from among all eligible entrants, during the sweepstakes period at the end of the Sweepstakes Period. Eligible Winners can only win once during the Sweepstakes period.

Odds of winning will depend on the number of eligible participants who enter the Sweepstakes.

Winners will be selected at the end of the Sweepstakes Period. Subject to verification of eligibility and compliance with these Official Rules.

6. **Winner Notification and Acceptance.** Potential winners will be notified within 48 hours after the Sweepstakes Period ends, at the telephone number provided from the entry.

To claim his/her prize, the potential winner must personally visit Sponsor's offices at 624 W. Muhammad Ali Blvd., Louisville, KY 40203 no later than Friday, November 30, 2018, 5:30PM. Office visits must be between the hours of 8:30 a.m. EST and 5:30 p.m. EST, and must present a valid government-issued photo ID.

Potential winners may be required to complete an affidavit of eligibility, and a liability and publicity release (except where prohibited by law).
